

WAIVER AND RELEASE BY GUEST AT CEDAR LAKE CAMP

The undersigned hereby agrees as follows:

1. I am executing this Waiver and Release in consideration for being allowed to visit Cedar Lake Camp (hereinafter, "**Camp**") under the sponsorship of the Sponsoring Organization identified below (hereinafter, "**Sponsoring Organization**").
2. I acknowledge that visiting the Camp entails risks and hazards which could result in bodily injury, personal injury, illness, and/or death, including, but not limited to, risks and hazards posed by Cedar Lake, trees and plants (such as poison ivy, poison oak, poison sumac, etc.), Camp activities, wildlife, parasites, pathogens (e.g., bacteria, viruses, and other microorganisms), allergens, wildfires, and various natural hazards and phenomena. Other risks and hazards may also exist.
3. I understand that Cedar Lake Camp, Inc. and Cedar Lake LLC (collectively, the "**CLC**") may establish rules to try to mitigate the risks and hazards associated with the Camp (collectively, "**Rules**"). I agree that I will obey and abide by all such Rules.
4. To my knowledge, I do not have COVID-19, multisystem inflammatory syndrome, or any other communicable disease and have not had a fever of 100.4 degrees or greater within the last fourteen (14) days. I agree that, if I begin exhibiting symptoms of a disease or illness, I will immediately notify the Sponsoring Organization of such symptoms and seek appropriate medical attention.
5. I understand that, even if the Rules are fully implemented and enforced, the risks and hazards associated with the Camp may not be eliminated. I assume and accept all risks of bodily injury, personal injury, illness, and/or death associated with my visit to the Camp.
6. To the maximum extent permissible under the law and in equity, I also waive, release, and forever discharge Cedar Lake Camp, Inc. and Cedar Lake LLC and their respective directors, officers, members, employees, representatives, agents, shareholders, and affiliates (collectively, "**CLC Parties**") from and against any and all present and future, suspected and unsuspected, claims, demands, debts, liabilities, medical expenses, costs (including costs of suit, expenses, attorneys' and expert witness fees), actions, causes of action, judgments, and other obligations arising out of or associated with my visit to the Camp, including, without limitation, claims for bodily injuries, personal injuries, and/or death (collectively, "**Released Claims**").
7. I also waive and relinquish any and all rights and benefits which I have or may have with respect to the Released Claims under Section 1542 of the California Civil Code, which states: "**A general release does not extend to claims that the creditor or releasing party does not know or suspect to exist in his or her favor at the time of executing the release and that, if known by him or her, would have materially affected his or her settlement with the debtor or released party.**" I agree that this Waiver and Release shall remain effective with respect to the Released Claims even if facts are subsequently discovered that differ from and/or are in addition to the facts that I now know or believe to be true.
8. I also agree to forever refrain and forbear from commencing, instituting, or prosecuting any lawsuit, action, or other proceedings against the CLC Parties arising out of, in connection with, and/or pertaining to the Released Claims.
9. This Waiver and Release shall be governed by and interpreted under California law.
